## **ONLINE PRIVACY STATEMENT:**

LINPAC Group Limited and its subsidiaries (hereinafter collectively referred to as "LINPAC") makes every effort to honour the preferences of LINPAC'S Web site users concerning the collection and use of personally identifiable information. This statement describes how LINPAC collects and uses personally identifying information of visitors to LINPAC'S Web sites.
